**Object : fundamental error of title within the Court's homepage – a fake Ministre of Justice; urgent request of rectification.**

Mister President,

After having spoken over the telephone today with Your Registrar,

I just saw, on this 30<sup>th</sup> of January 2013, Your picture taken alongside the Director of Judicial Services of Monaco, Mister Philippe Narmino, who is currently subjected to a criminal complaint for having illegally claimed to be and acted as a minister of Justice. It is paramount for Monaco's obligations to the Council of Europe for the latter to take legal notice of the fact that Monaco is devoid of any a minister of Justice.

This answerable to Justice is currently under the yoke of pending criminal affairs within which he faces life in jail under article 137 of the Monegasque Criminal code, within its last paragraph. Many a Government has been warned. Indeed, I am the Editor and publisher in Sweden of BIMCAM, an acronym certified by an instruction judge as standing for Burglary in Monaco Cambriolage A Monaco. The responsible? Philippe NARMINO.

Monaco being devoid of a free press, I ask You kindly to confirm or infirm to me Philippe Narmino's quality as guest of honour as described in Monaco-Matin on the 29<sup>th</sup> of January 2013, in light of how badly this reverberates, some month prior to the deadline for Monaco to comply to GRECO's report ([http://www.coe.int/t/dghl/monitoring/greco/evaluations/round3/GrecoEval3\(2011\)5\\_Monaco\\_One\\_F\\_R.pdf](http://www.coe.int/t/dghl/monitoring/greco/evaluations/round3/GrecoEval3(2011)5_Monaco_One_F_R.pdf)).

Through illegal request of mutual legal assistance, the very NARMINO just happened to put into question my reports on mafia methods currently in use in Monaco. Indeed, he just had a trial to take place against myself and a third party, with refusal of access to any an information to the concerned Embassy (of Sweden, in Paris, see attached document). The police reports on Philippe Narmino, which are at the hands of the Swedish authorities, are alarming. They are at Your disposal.
